AMENDMENT TO THE BYLAWS FOR TIMBERCREEK HOMEOWNERS ASSOCIATION, INC.

WHEREAS, pursuant to Article XII of the By-Laws, the Bylaws may be altered, amended or repealed by majority vote of the Directors present at a duly constituted meeting of the Board of Directors.

WHEREAS, the Amendment set forth herein is for the purpose of amending the By-Laws for TIMBERCREEK.

WHEREAS, the amendment set forth does not materially affect a Unit Owner's share of the common elements nor impair or prejudice the rights and priorities of lienors or mortgagees.

NOW, THEREFORE, Declarant makes this Amendment to the By-Laws as follows:

- I. This Amendment hereby amends Article VIII, Section 11 of the By-Laws as follows: (additions indicated by <u>underline</u>, deletions indicated by <u>strikethrough</u>)
 - "11. No member shall serve on the Board of Directors for more than four (4) consecutive years following their first election and no officer shall serve in the same office for more than two (2) consecutive years."
- II. Except as amended and modified herein, all other terms and conditions of the By-Laws for TIMBERCREEK shall remain in full force and effect according to their terms.
- III. This Amendment has been proposed and adopted by a majority vote of the Directors.
